***NARRATIVE: On March 4th, 2019 at 2:04 AM Medford Township Police were dispatched to the 200 block of Medford-Mt. Holly Road. The 911 caller reported that a male had broken into the residence and was currently on the 1st floor. Upon the arrival of Police, a black BMW was observed unoccupied in the front yard of the residence. The vehicle was disabled on location and police subsequently determined that a subject had in fact forced entry into the home. Police quickly located a subject on the 1st floor, identifying him as Tyrell Powell (35) of Mt. Laurel. Powell was arrested without injury and charged with defiant trespass, criminal mischief, being under the influence of a controlled dangerous substance, as well as motor vehicle tickets. The investigation into the incident is ongoing.***
